**Subject: Payment for Post-Matric Scholarship under MoTA, GoI for AY/FY 2021-22.**

Payment for Post-Matric Scholarship to ST students under Ministry of Tribal affairs, Govt. of India for AY/FY 2021-22 has been initiated in NSP Payment Portal viz. nsp.gov.in/pmnt through NSP-PFMS-DBT module first time as pilot basis. During disbursement of payment, it is observed that some ST students have been credited with less amount and some with higher amount in respect of actual amount.

2. Details of ST students receiving higher amount has been enlisted at Annexure-I. Students receiving higher amount will have to return the excess amount to the Tribal Welfare Department, Govt. of Tripura by 5<sup>th</sup> April, 2022 positively. 3. Details of ST students receiving less amount has also been enlisted at Annexure-II. Balance amount shall be disbursed shortly to the bank account of the concerned ST students who received less amount in respect of actual amount.
