The Tribal Welfare Department, Government of Tripura hereby invites online application from the interested unemployed ST youths of the state of Tripura having Annual family income not more than Rs.2,50,000/- for undertaking Free Job Oriented Coaching classes in the following Courses, 2022-23. *A Student/ candidate who has already availed/ availing Free Job Oriented Coaching provided by this Directorate earlier (March 2022 to September 2022 including one year course of TCS/TPS) shall not be selected/ eligible for applying for this Session

4. Financial support to be provided under the scheme to selected ST students:

The course fee against each student beneficiary shall be provided to the empanelled institution in two phases, i.e 50% once the beneficiaries have enrolled themselves in the institutions (both in biometric & hard copy admission register) and the rest 50% at the time of completion of course (based on biometric attendance system).

5. Eligibility Criteria of the interested Unemployed ST Youth:


- a. **Must be domicile of Tripura- Self PRTC to be uploaded.**
- b. **Must belong to ST Community of Tripura-ST Certificate/ any other document as proof of being an ST like Post-Pre matric scholarship acknowledgment slip/ merit award acknowledgment slip/ certificate to be uploaded.**
- c. **The Annual Family Income of the interested unemployed youth should not be more than Rs.2,50,000/- latest Income Certificate issued by DCM or SDM of the subdivision to which the unemployed youth belongs to be uploaded.**
- d. **Must be at least X (Madhyamik) or equivalent passed for Gr-D recruitment Exam, Graduate with 50% marks for remaining and B.Ed/ D.El.Ed for teaching related courses.**
- e. **Shall not be regular student in any Institution.**
- f. **Shall not be regular employee in any Govt. / Private Organization.**

6. Procedure for selection of beneficiaries & Counseling programme :-

- a. **Interested students shall submit their online application through the link provided in the Departmental website (<https://twcet.tripura.gov.in>).**
- b. **Based on the mark obtained in Madhyamik (X), the Merit list shall be prepared by the Directorate of Tribal Welfare (DTW).**
- c. **On the day of Counseling Program, candidates/ beneficiaries will be given opportunity (merit wise) to choose the course and the Institution of their choice among the Empanelled Institution and course offered as well as keeping in mind the Institute wise course targets.**
- d. **Based on the choice of the candidates and availability of seats the candidates/ beneficiaries shall be instantly admitted to the Coaching Centre of his/her choice.**
- e. **During counseling, an undertaking will be taken from the enrolled candidates/ beneficiaries on the following issues:**
 - i. **He/ She will not leave the course midway and shall continue the course till completion of course duration.**
 - ii. **He/ She will appear in atleast one exam of the course for which she is undertaking the coaching or any other exam for which course is imparted by the coaching institute.**

7. Terms and conditions:

- a. **Any decision taken by the Tribal Welfare Department, Govt. of Tripura shall be treated as final.**
- b. **The Department reserves the rights to reject any application which is incorrect/ incomplete application or submitted after expiry of the application date.**
- c. **If any document is/are found to be false or fake, the benefit shall be terminated and the institutions shall return the sanctioned amount against such students.**
- d. **The Tribal Welfare Department will have the power to amend or withdraw the notification without any reason and total seats allocated may increase or decrease as per the decision of the authority.**
