- **1.** New students for the academic year 2023-24 or who have not applied scholarship for the academic/ financial year 2022-23 should apply as **"FRESH".**
- **2.** The students who have applied application (scholarship) in National Scholarship Portal (NSP) and verified successfully during the academic/ financial year 2022-23 should apply as "**RENEWAL**" for AY/FY 2023-24.
- **3.** Students should submit the printed copy of online application along with required documents to the concerned Institution for **Level-1** verification.
- **4.** The students who are pursuing their studies **outside the State** should also submit the printed copy of online application along with required documents (as up-loaded in online) to the **O/o the District Welfare Officer** of the concerned District before the deadline for **Level-2** verification.
