NOTIFICATION

Subject: Payment of Pre-Matric/Post-Matric Scholarship to ST students for the AY/FY 2021-22 through NSP-PFMS-DBT module - request for updating Bank Accounts of ST students thereof.

Payment for Pre-Matric(Class-IX & X) /Post-Matric Scholarship to ST students under the Scheme of "Umbrella Scheme for Education of ST Children-Pre & Post- Matric Scholarship(CSS)" for AY/FY 2021-22 has been initiated in National Scholarship Payment Portal viz. nsp.gov.in/pmnt, through NSP-PFMS-DBT module first time as pilot basis.

- 2. During disbursement of payment, it is observed that some ST students have been credited with amount in the Bank Account already registered by the particular ST student in the National Scholarship Portal (NSP). Besides, many ST students have been credited with amount in **AADHAR** based Account instead of Account already registered in NSP. Updated/Activated Bank Account is invariably required for successful payment through

 NSP-PFMS-DBT mode irrespective of AADHAR linked Bank Account already registered in NSP or any other Bank Account of the particular ST student linked with AADHAR.
- 3. Under the above circumstances, all concerned ST students are hereby requested to **Update/Activate** all their Bank Accounts viz. Bank A/C already registered in NSP and other Bank Account, if any, at an early date to avoid failure of payment through NSP-PFMS-DBT mode in connection with Pre-Matric(Class-IX & X) /Post-Matric Scholarship to ST students for the AY/FY 2021-22.
- 4. All concerned Head of the Institutions are also requested to take necessary action and direct the concerned ST students in updating/activating their Bank Accounts(all type) at an early date.
